



- d) Players who have participated or won medal(s) in the competitions given at para 4(b) above during the period from 31/12/2022 till 30/12/2024 shall be eligible for recruitment to the post of Constable/GD (Sportsperson) in BSF.
- e) Candidates will be given marks for medals won or level of participation during aforementioned time period only.

**(v) Appeal against Detailed Medical Examination: -**
