NOTIFICATION

The contractual post of Senior Research Fellow (Irrigation) is to be filled-in the project on "Gradual Development of Irrigation Management System for Continuous Assessment of Performance/Benchmarking of Pench Irrigation" research project at Interfaculty Department of Irrigation Water Management, Mahatma Phule Krishi Vidyapeeth, Rahuri. Purely on Contract and Temporary basis. This project has aims to develop online platform to monitor irrigation performance of the system in terms of equity, reliability, efficiency and grading with respect to various benchmarking parameters related to irrigation service delivery. The irrigation performance/management system include: Database management, Development of analytical dashboard, Development of asset management system, providing suggestions for maintenance/rectification/improvement of water delivery structures wherever necessary, Generation of reports and web stories, Analysis report and Dissemination of information to various stakeholders.

Age limit:

- 1) Senior Research Fellow (SRF) - The Upper age limit will be 35 years for men and 40 years for women.

Conditions

- a) It is the responsibility of the candidate to submit the application and to attend the interview in person on scheduled date and time as communicated by email/text message.
- b) The post is purely on a temporary basis for the specified period stated in this notification and the candidate is subjected to termination on the expiry of the period or the project or by giving the notice of one month from either side.
- c) Canvassing in any form will make the candidate ineligible.
- d) The candidate should bring photo identity which needs to be produced during the "Verification of Document" Process or interview.
- e) It is to inform to note all the terms and conditions of the temporary employment as stated below.

Terms and Conditions:

1. Appointment is of purely on temporary basis and for six months subjected to the termination on closing of / termination of project. The candidature of the candidate will be cancelled at any time without giving reason(s) thereof.

4. If candidates are more, written test will be taken for screening the candidates and after screening selected candidates will be interviewed by the Selection Committee.

The selected candidates will have to work at "Gradual Development of Irrigation Management System for Continuous Assessment of Performance/Benchmarking of PENCH Irrigation" research project under Interfaculty Department of Irrigation Water Management, Mahatma Phule Krishi Vidyapeeth, Rahuri or within its jurisdiction in the field /laboratory and office, as per the mandate of the project, at MPKV, Rahuri, for the entire term as full

time worker and they will not be allowed to accept any other appointment/assignment during this period.

6. The notification does not mean that all the posts will be necessarily filled. The discretionary power will rest with the Selection Committee constituted for the purpose.

The appointment of the selected candidate for the said post shall be a tenure appointment and purely on temporary basis (eleven months) and likely to be terminated at any time without assigning any reason thereof and candidate shall not have any right of claiming permanency benefit of the said post or such posts by virtue of this appointment.
