

Terms and conditions:-

1. Computer knowledge is must for JRF Post.
2. Candidate applying for the post of JRF should have proficiency in both Marathi and English; he/she should have skill to carry out correspondence in both Marathi & English languages.
3. The applicant should not have criminal tendencies or background. If found the contract will be terminated immediately.
4. Office of Deputy Conservator of Forest, Bhandara will be the Headquarter for above posts. All the above selected persons will be required to work in all the Forest Ranges in Bhandara Forest Division. Candidate must have his own vehicle (Two Wheeler) for the field visit.
5. If all the qualifications of the eligible applicants for a post are found to be the same, preference will be given to the applicant who is resident of Bhandara District.
6. Contract employees will be paid an emolument basis after completion of one month.
7. Deputy Conservator of Forest, Bhandara reserves the rights to decrease monthly emolument, if non performance or delay in the work is observed.
8. In case of financial loss to the Government due to negligence of the contractual employees, the compensation will be recovered from the employees.
9. If the Deputy Conservator of Forest, Bhandara satisfied with candidates work done in 11 months of the contract, the contract may be extended on the recommendation of Field Officers i.e. RFO's and ACF's in Bhandara Forest Division.
10. **These posts will be filled purely on contractual basis and are not created by the Government of Maharashtra. The applicants selected for these posts, will not have any claim for the post of government establishment or right to remain in the permanent service.**
11. Deputy Conservator of Forest, Bhandara shall have the right to dismiss and terminate the contract employees without giving any prior notice or without giving any reason before the completion of 11 months.
12. If the employee wants to leave the job before the completion of 11 months, he / she will be allowed to cancel the contract by giving one month notice in advance.
13. Deputy Conservator of Forest, Bhandara is bound to pay the emolument till the contract is valid.
14. It will be mandatory for employees to observe confidentiality of government documents and correspondence. Also, in case of misuse of government information, the concerned employee will be held responsible and action will be taken as per prevailing rules and regulations.
15. Government documents issued in the jurisdiction of the contractual employees should be submitted to the office after completion of the bond (All documents, books and other materials). The candidates are not supposed to take any document with them. If found action will be taken as per rules.
16. Candidate should not be a officer-bearer/post holder of any Government, Semi- government or Non- Government Organization.
17. As these posts are full time, the candidate shall not work or practice elsewhere after selection on post.
